The Regular Meeting of the Housing Authority of the City of Vineland was called to order by Chairman Robert A. D'Orazio on Thursday, May 17, 2012 at 7:00 p.m. at the office of the Authority located at 191 W. Chestnut Avenue, Vineland, New Jersey 08360. The following Commissioners were present:

Also present were Jacqueline Jones, Executive Director, Wendy Hughes, Assistant Executive Director, Charles W. Gabage, Esquire – Solicitor, Dan Avena and Linda Cavallo from the VHA's fee accounting firm and Gloria Pomales, Executive Assistant.

Chairman D'Orazio read the Sunshine Law.

The Chairman entertained a motion to approve the minutes of the Regular Meeting held on April 19, 2012. A motion was made by Commissioner Ruiz-Mesa and seconded by Commissioner Gordon. The following vote was taken:

Chairman D'Orazio called for the Financial Report from Avena's office. Linda Cavallo reviewed the Financial Report for the seven months ending April 30, 2012.

Chairman D'Orazio requested the Executive Administrative Report. Mrs. Jones reported there is an initiative with HUD to hold a Father's Day event at the VHA's family sites. The VHA is currently conducting a survey to see how many participants the VHA would have if the event was held. She also reminded everyone that there will not be a summer program this year at the Corbin Center. The VHA is trying to connect the residents with the YMCA or any other program in the area.

Mrs. Jones advised the Board that the VHA will be having a HUD site visit, which hasn't been done in over 5 years. The VHA received a call from its HUD Engineer for two purposes. An audit must be done in regards to the competitive green money the Authority received for Parkview and D'Orazio. This is called a remote audit. During the time he VHA was gathering the information for the HUD Engineer for the green money audit, the Engineer received a call from Washington that he had to conduct an onsite visit since he has not visited in a while.

Mrs. Jones stated the Authority has filed the Public Housing Family Self Sufficiency application today. The Authority received this grant for the first time last year and the renewal is due in two weeks. Hopefully the Authority will receive this grant again. There are currently 25 active participants on the FSS program already.

The VHA was finally able to get a meeting with NJHMFA (Housing Mortgage Finance Agency) to discuss the Chapman Terrace project on Monday. Mrs. Jones should have more information next month to report.

Chairman D'Orazio asked if the reason for the cancellation of the summer program was budgetary. Mrs. Jones said yes. The summer program cost the Authority up to \$60,000-\$80,000. In salaries alone it costs approximately \$50,000. The program is really hard to manage. The ratio of teachers to children almost has to be 2 to 1. There were a lot of behavioral problems last year. Mrs. Jones briefly explained the program. The Authority would like to continue to maintain the afterschool program.

Mrs. Jones reported she had a preliminary meeting with the accountants regarding the 2013 Budget. The 2013 budget will be brought back to the Board in the next couple of months for discussion. Last year the Authority waited as long as it could to see what is going on in Washington in order to write as real as a budget as possible. The numbers currently from Washington seem to be on target with the current year's funding.

Mr. Gabage questioned the HAP payment amount on the Financial Report. Mrs. Jones explained when initially preparing the budget the recapture was not included. There was a brief discussion regarding the recapture. The line adjustment is on the second page of the Financial Report.

With no other discussion in related matters the Chairman moved to the Resolutions.

Chairman D'Orazio called for a report from Commissioner Ruiz-Mesa. Commissioner Ruiz-Mesa reported he reviewed all the bills and recommended payment in the sum of \$364,410.30.
