REGULAR MEETING Thursday, April 19, 2018 7:08 p.m.

The Regular Meeting of the Housing Authority of the City of Vineland was called to order by Solicitor Charles Gabage on Thursday, April 19, 2018 at 7:08 p.m. at the office of the Authority located at 191 W. Chestnut Avenue, Vineland, New Jersey 08360.

Also present were Jacqueline Jones, Executive Director, Wendy Hughes, Assistant Executive Director, Charles W. Gabage, Esquire – Solicitor, Linda Cavallo – Accountants, Rick Ginnetti, The Brooke Group and Gloria Pomales, Executive Assistant.

Solicitor Charles Gabage read the Sunshine Law.

Solicitor Charles Gabage entertained a motion to approve the minutes of the Regular Meeting held on February 28, 2018. Tabled for next month.

Solicitor Charles Gabage entertained a motion to approve the minutes of the Regular Meeting held on March 22, 2018. Tabled for next month.

Solicitor Charles Gabage entertained a motion to approve the minutes of the Executive Session held on March 22, 2018. Tabled for next month.

Solicitor Charles Gabage called for the Financial Report from the Fee Accountant. Linda Cavallo reviewed the Financial Report for the six months ended March 31, 2018.

Solicitor Charles Gabage requested the Executive Administrative Report. Mrs. Jones just wanted to mention Mr. Avena is not present tonight due to illness. This is the first meeting in thirty plus years he has missed. He is recovering and doing better.

Mrs. Jones does not have any new updates to her written report. She requests that the meeting move forward. She will comment during Mr. Ginnetti's presentation during the old business portion of the meeting.

Committee Reports: None.

<u>Old Business</u>: Rick Ginnetti, Consultant, reported to the Board. In regards to the RAD transaction for Tarkiln/Asselta, the Local Finance Board approved the housing authority to issue tax exempt bonds up to \$2.4 million dollars. The housing authority can now proceed to a closing for the RAD conversion of Tarkiln/Asselta in July/August of 2018.

As a note, the bond issuance was initially going to be done through the Cumberland County Improvement Authority (CCIA) and has since moved to the housing authority and it was mentioned that the professionals from CCIA wanted to contract directly with the housing authority. Parker McCay and Phoenix Financial Services at the time were discussed. The VHA asked for proposals from Parker McCay and Phoenix Financial Services. Phoenix Financial Services provided a proposal prior to the last board meeting, which was under the VHA's budget. Parker McCay did not provide a proposal and it took about a week and an half to obtain one. The proposal was significantly higher than we were initially advised. Mrs. Jones requested Mr. Ginnetti to reach out to another Bond Counsel and obtain other proposals. Two proposals were received and were better than Parker McCay's. Archer & Greiner was financially better among all of them. It was decided to use Archer & Greiner. Based on time and material, they represented the VHA at the Local Finance Board. There is a resolution tonight to appoint them as Bond Counsel for this transaction and the back-up information is attached. Mrs. Jones stated Parker McCay's proposal was in the amount of \$50,000 which was the number budgeted for legal expenses. The VHA never officially received a written proposal from Park McCay. Mr. Ginnetti stated an email received stating the cost was \$50,000 but an official proposal was never received. There was \$50,000 in the budget for legal costs for additional legal costs besides the Bond Counsel. The Authority is asking the Board to appoint Archer & Greiner as the Bond Counsel. The meeting at the Local Finance Board went well. Mr. Gabage vouched for Archer & Greiner and rates them higher than Parker McCay. Archer & Greiner's proposal is not to exceed \$35,000. Mr. Ginnetti stated Capital Bank is prepared. The Phase I Environmental Review was completed. The appraisal has also been completed.

Mr. Ginnetti stated last month the Board passed a resolution to send an application to the NJ Local Finance Board. The board will now need to approve another resolution to approve issuing the bonds. This resolution will be presented to the Board tonight. Once this resolution is approved it will authorize Archer & Greiner to complete the bond documentation and work with Capital Bank to finalize the sale of the bonds. Also on the agenda tonight, is a resolution to approve the formation of a non-profit Affordable Housing Corporation as it was discussed at last month's meeting. The purpose of the Affordable Housing Corporation is to be the "receiver" of the Housing Assistance Payments for the RAD conversion.

New Business: None.

With no other discussion in related matters the Solicitor Gabage moved to the Resolutions.
