Chairman Ruiz-Mesa called for the Financial Report from the Fee Accountant. Linda Cavallo reviewed the Financial Report for the eight months ended May 31, 2020.

Chairman Ruiz-Mesa requested the Executive Administrative Report. Mrs. Jones stated the Authority is still operating the same as last month since the COVID-19 pandemic. The Authority is working on a policy to permit the maintenance staff to begin working on routine work orders. Currently, maintenance is only entering resident units for emergencies and using the appropriate PPE. The residents are also using the appropriate PPE.

Mrs. Jones updated the Board regarding the funding that was received from the Cares Act which totaled between Section 8 and Public Housing about \$225,000. The Cares Act basically provided housing authorities with 2 month's operating subsidy for public housing side and 2 month's administrative expenses for Section 8. There was some confusion as to what this funding could be used for. Mrs. Jones attended a webinar yesterday. The funding can be used on any approved operational expense. The suggestion is that the Authority use the funds for utilities, taxes and payroll. The reason is this \$225,000 has a sunset date of December 31, 2020, and if we do not spend it then it goes away. Mrs. Jones stated the Authority has spent approximately \$50-60,000 to date on COVID-19 related expenses.

The RAD conversion for Kidston and Olivio is still in progress. The consultant, financial advisor, attorney for the bond transaction and Mrs. Jones presented in front of the Local Finance Board viavideo conferencing last Wednesday. It went well. The Authority received a verbal positive finding. The next steps are to get the positive finding in writing from the Local Finance Board, forward this on to the bank and to HUD for final approvals. The goal is to convert these two properties by the end of this calendar year. HUD schedules the last closing in November with a December 1st effective date. After this conversion, the only properties remaining under public housing will be D'Orazio and the Scattered Sites.

Mrs. Jones asked if any Board Members have any questions. No questions from the Board regarding her report.
